

# Phase II preparations for Mary's Shrine Building Program near completion

Final plans drawn for new, 2,000-seat Shrine Church

ORLANDO, Fl. — With the final weeks of 1987, plans and blueprints for the Main Church at Mary's Shrine are themselves being finalized.

Present specifications call for worshipers to enter through five, 18-foot-high doors, each artistically rendered in bronze relief. Inside the spacious, skylit forecourt, or narthex, the focal point will be a sculptured, Baptismal Font — its ever flowing waters a reminder to all that we come to Christ through the ever flowing outpour of God's saving grace.


Passing through the narthex, visitors will enter the nave, the central assembly space on axis with the sanctuary and 60-foot-high clerestory barrel vault. This will terminate at the daily liturgy chapel located behind the sanctuary.


By design, the 2,000-seat nave, with standing room for an additional 1,000 worshipers, will be a room-within-a room. This effect is created by the 'layering' of natural and manmade design

Thus, exterior gardens on either side of the chapel and beyond the sanctuary will actually be visible from within the chapel itself. In addition, the back walls of this devotional garden will provide an audio and visual buffer from the nearby interstate highway, and serve as well as a backdrop for major works of art and sculpture. Indeed, the Shrine's Catholicism and the new Liturgy will be confirmed by a garden placement of the Twelfth Station, a Calvary sculpture, outside the etched glass wall of the chapel, yet within the Shrine proper.

A similar garden will contain a counterpoint sculpture of The Nativity to symbolize the beginning of Christ's life, and announce the Patroness of the Shrine. Liturgically, these two gardens will represent the coming and the end of Christ's life on earth.

While details of the Church interior remain incomplete, 14 Magnificat Windows, alternating with 16 Rosary Windows, will il-

Dear Friend of Mary's Shrine,

I share with you this monumental expression of faith because it was evident that neither torrential rains nor lightning and thunder could daunt those who saw Jesus Christ in the person of His Chosen representative, Pope John Paul II.



### Tax-saving ways to help support the building of Mary's Shrine

hile the most popular form of charitable contribution remains the gift of cash, our nation's tax laws make possible several other, important ways to provide meaningful support—and receive substantial tax benefits in return.

### • Gifts of Appreciated Securities

Stocks, bonds and mutual funds which have appreciated in value since their purchase can make attractive charitable gifts.

When a *sale* of this type of property is made under current law, any difference on a sale of property between the cost basis and the fair market value is taxed to the donor at ordinary income rates.

However, when a *gift* of this type of property is made, the donor receives an income tax deduction for the *full* fair market value of the stock on the date of the transfer and also avoids the tax that would have been paid had the security been sold rather than donated.

Consequently, stocks that have appreciated in value not only make attractive gifts, they also provide an avenue for making much larger gifts than might otherwise be possible.

In all, gifts of appreciated property may be deducted up to 30% of their adjusted gross income, with the tax

deductions spread over as many as five years.

For example, Mr. and Mrs. Cole purchased QWT, Inc. stock for \$2,000. Three years later, it has a value of \$20,000. If Mr. and Mrs. Cole make a gift of the stock to the Shrine, they receive a charitable deduction of \$20,000. Because the stock is being contributed to a not-

for-profit corporation, the Coles also avoid the capital gains tax. And since the gift itself can be deducted up to 30% of adjusted gross income, any excess can be carried forward into as many as five additional tax years!

#### Real Estate


Rather than dipping into current cash flow or retirement savings to make a substantial gift, many donors may find it in their best interest to give a gift of land which has risen in value since its original purchase price. Such gifts are treated exactly like appreciated stock under the new tax law: the property is given and a deduction taken for the full fair market value of the contribution—even though the cost may be significantly lower.

#### • Personal Property

Many donors fail to realize the number of assets other than cash and appreciated property which also have valuable gift potential.

In fact, under current law, donors may make a gift of any type of personal property to Mary's Shrine and enjoy a charitable contribution deduction. If we can actually use the property in our work, the deduction would be for the full market value at the time of contribution. If the tangible item(s) would be best sold and proceeds used by the Shrine, the deduction would be equal to the cost basis of the property.

(I had not planned to add a second, personal message in this issue of our Shrine newsletter. But I did not want you to miss this very special prayer opportunity.)


More than a decade ago, I made a promise to our Blessed Mother in the Basilica at Lourdes.

The year was 1976. I had gone to Lourdes — "this place of miracles" — to ask Mary's blessing upon our new parish church which was then under construction in Orlando. And, indeed, I too found Lourdes to be a place of miracles: No, I was not witness to extraordinary cures. But what I did witness was the miracle of faith.

Even today, I recall the shining face of one very old man, kneeling at the place where Mary had appeared. There he remained, arms outstretched, his tired body straining, for what seemed a remarkablly long time. And he was but one of thousands who came that day, trusting in God, and through love of our Blessed Mother!

While at Lourdes I took the traditional pilgrims' bath in the freezing mountain waters of The Gave —

the river where Mary first appeared to Bernadette and her friends.



Yet I do not want to return to Lourdes without taking something of you - and your prayers - with me.

That night I joined with other pilgrims on the candlelit procession at the magnificent Lourdes Basilica. After mass, I lit a candle in the Basilica, and asked Mary to continue to light the way for me in my own journey of faith. And I promised one day to return and give thanks.
